Land Use – C (Commercial) and R- L/MD (Low Medium Density Residential)

Zoning – RS-5 (Single-Family), CF (Community Facility), RM-12 (Multi-Family Residential), RM-16 (Multi-Family Residential), RD-10 (Two-Family Duplex Residential), B-2 (Central Business), RO (Residential Office), and RO SC-2 (Residential Office Service-Controlled)
